Subject:- Filling up one post of Planning Officer in the Directorate of Health & Family Welfare, U.T Chandigarh.

I am directed to refer to address you on the subject cited above and to so that one post of Planning Officer (Group A) in the Directorate of Health & Family Welfare, Chandigarh Administration in the pay band of Rs.15600-39100/- plus 5400/- Grade Pay on deputation basis initially for a period of one year but not exceeding 5 years is to be filed up as under:-

“COMPOSITE METHOD [DEPUTATION (ISTC)

PLUS PROMOTION]

OFFICERS UNDER CENTRAL GOVT./ STATE GOVERNMENT/ U.T. ADMINISTRATIONS, PUBLIC SECTORS UNDERTAKINGS/UNIVERSITIES/ RECOGNISED RESEARCH INSTITUTIONS/ SEMI GOVT. ORGANISATIONS/AUTONOMOUS BODIES/ STATUARY ORGANISATIONS.

(A) (I) HOLDING ANALOGOUS POSTS ON REGULAR BASIS IN THE PARENT CADRE/ DEPARTMENT; OR

(II) WITH TWO YEARS SERVICE IN THE GRADE RENDERED AFTER APPOINTMENT THERETO ON A REGULAR BASIS IN POSTS IN PB-2, RS. 9300-34800/- WITH GRADE PAY OF RS. 4800/- OR EQUIVALENT IN THE PARENT CADRE OR DEPARTMENT; OR

(III) WITH THREE YEARS SERVICE IN THE GRADE RENDERED AFTER APPOINTMENT THERETO ON A REGULAR BASIS IN THE POST IN PB-2, RS. 9300-34800/- WITH GRADE PAY RS. 4600/- OR EQUIVALENT IN THE PARENT CADRE OR DEPARTMENT; AND

(B) POSSESSING THE FOLLOWING EDUCATIONAL QUALIFICATIONS AND EXPERIENCE.

(I) BACHELOR'S DEGREE FROM A RECOGNIZED UNIVERSITY/ INSTITUTE;

(II) THREE YEARS EXPERIENCE IN THE ADMINISTRATION AND ESTABLISHMENT MATTERS IN A GOVT. DEPARTMENT.

NOTE 1 : THE DEPARTMENTAL SUPDT GR-II IN THE PAY BAND; 3; 10300-34800 PLUS GRADE PAY OF RS 4800/- WITH TWO YEARS REGULAR SERVICE IN THE GRADE WILL ALSO BE CONSIDERED ALONGWITH THE OUTSIDERS AND IN CASE HE/SHE IS SELECTED FOR APPOINTMENT TO THE POST, THE SAME SHALL BE DEEMED TO HAVE BEEN FILLED UP BY PROMOTION

NOTE 2: THE DEPARTMENTAL OFFICIALS IN THE FEEDER CATEGORY WHO ARE IN THE DIRECT LINE OF PROMOTION WILL NOT BE ELIGIBLE FOR CONSIDERATION FOR APPOINTMENT ON DEPUTATION. SIMILARLY, DEPUTATIONISTS SHALL NOT BE ELIGIBLE FOR CONSIDERATION FOR APPOINTMENT BY PROMOTION.

(PERIOD OF DEPUTATION (ISTC) INCLUDING PERIOD OF DEPUTATION (ISTC) IN ANOTHER EX-CADRE POST HELD IMMEDIATELY PRECEDING THIS APPOINTMENT IN THE SAME OR SOME OTHER ORGANIZATION /DEPARTMENT OF THE CENTRAL GOVT, SHALL ORDINALLY NOT TO EXCEED THREE YEARS. THE MAXIMUM AGE LIMIT FOR APPOINTMENT BY DEPUTATION (ISTC)

SHALL BE NOT EXCEEDING 56 YEARS AS ON THE CLOSING DATE OF THE RECEIPT OF APPLICATIONS).

It is, therefore, requested that the names of suitable candidates possessing required qualification/criteria/age etc. and whose services can be spared may be sent to this administration within 60 days on or before 31-07-2018 by 5:00 P.M. along with gist of A.C.R's of last 5 years along with no disciplinary inquiry/ criminal proceedings are pending or likely to be initiated against them in near future and integrity certificate and vigilance clearance certificate of the officials. The panellist should not cross the age of 56 years and has been working in the cadre and should not be in the higher pay scales and has not crossed the maximum of the scale of pay of the post in question.

This may be treated as most urgent to avoid any legal complication/contempt.
